

## LICENCE TO USE THE VOCABULARY MAPPING FRAMEWORK

### Introduction

The **Vocabulary Mapping Framework** (VMF) is a downloadable tool, originally funded by JISC (<http://www.jisc.ac.uk>) and currently administered by the International DOI Foundation ([www.doi.org](http://www.doi.org)), to support interoperability across communities by providing extensive and authoritative mapping of vocabularies from content metadata standards and proprietary schemes. The new vocabulary is not intended as a replacement for any existing standards, but as an aid to interoperability, whether automatic or human-mediated. The Framework includes mappings of terms from code lists or allowed value sets in the existing standards to the RDA/ONIX vocabulary, enabling the computation of “best fit” mappings between any pairing of standards.

HEFCE on behalf of JISC encourages the use of the VMF and this Licence governs any current or future use by You of the VMF.

Whilst this Licence permits You to use the VMF, HEFCE on behalf of JISC does not accept any liability for Your implementation of the VMF, which is Your sole responsibility. PLEASE READ THE DISCLAIMER SET OUT IN CLAUSE 7 BELOW.

### 1. Definitions

“**HEFCE**” means the Higher Education Funding Council of England

“**IDF**” means International DOI Foundation

“**JISC**” means the JISC Information Systems Committee

“**VMF**” means the VMF specifications and supporting documentation (including, without limitation, schemas and Document Type Definitions (‘DTDs’)) as published and updated from time to time on the VMF Website;

“**VMF Website**” means <http://www.doi.org/VMF.html> or any subsequent URL to which the same material is transferred. “**You/Your/Yourself**” means the individual and the organisation they work for who are seeking to make use of the VMF.

### 2. Acceptance

2.1 By downloading, importing, copying, abstracting from, modifying, circulating or implementing the VMF, You enter into a licence with HEFCE on behalf of JISC to use those standards in accordance with the terms and conditions set out below, as modified from time to time under the terms of Clause 6 (“the/this Licence”).

2.2 No registration is required to use the VMF, and use within the terms and conditions set out in this Licence is without charge.

### 3. Scope of Your rights to use the VMF

3.1 HEFCE on behalf of JISC grants You a non-exclusive, non-transferable, royalty-free, perpetual worldwide licence to use the VMF for the purposes of:

- Implementing the VMF for mapping and transforming controlled vocabularies, on Your own behalf or on behalf of third parties, whether for commercial use or otherwise; and

- Informing the content of controlled vocabularies which You wish to develop;
  - 3.2. For the purposes specified above, You can:
    - Download, import copies of the VMF into electronic files and print out or make copies of it or component parts;
    - Make copies of the VMF available in print or electronic form to others, subject to paragraph 4 below;
    - Amend, abridge, abstract or modify the VMF, bringing in Your own schema and
    - Copy and use as required any DTDs, schemas or other technical tools published from time to time on the VMF Website in support of implementation of the VMF.

#### **4. Preserving the Integrity of the VMF**

- 4.1 You must ensure that any copyright notices, and/or references to this Licence, which appear in association with the VMF or on the VMF Website are kept intact.
- 4.2 You will ensure that any documents which You create (whether in print or electronic form) which contain any reference to the VMF or any versions of the VMF which you create will attribute those standards clearly to the VMF and where practicable, links should be made to the VMF Website.

#### **5. Changes to the VMF**

- 5.1 IDF may make changes and improvements to the structure of VMF from time to time. IDF will circulate notifications of these changes on the VMF Website. The content of VMF will change as new terms and vocabularies are added to it. You should check the VMF Website from time to time to ascertain whether the version of the VMF which You have downloaded continues to remain current.
- 5.2 IDF and/or JISC also reserves the right to withdraw the VMF at any time and will notify of such withdrawal on the VMF Website. Any withdrawal of any of the VMF will not affect this Licence which will, subject to Clause 9, continue in full force and effect unless otherwise notified on the VMF Website.

#### **6. Changes to this Licence**

- 6.1 HEFCE on behalf of JISC reserves the right to change the terms of this Licence at any time. Such changes will have no retrospective effect. Such changes and any updated version of this Licence will be available through the VMF Website.

#### **7. Warranties and Disclaimer**

- 7.1 HEFCE on behalf of JISC warrants that it has the necessary rights to license Your use of the VMF in accordance with Clause 3.
- 7.2 Except as expressly stated in Clause 7.1, or as required by law, HEFCE on behalf of JISC provides no other warranty, express or implied.
- 7.3 Any implementations and/or amendments of the VMF are made at Your sole risk. Accordingly, IDF and/or JISC accept no responsibility or liability for:
  - 7.3.1 Any software, service or any other implementation of the VMF made by You or any third party; or

- 7.3.2 You making any decision, or refraining from making any such decision, based wholly or partly on any data, expression of opinion, statement or other information contained in the VMF.
- 7.4 It is Your sole responsibility to obtain any patent licence or other permission required for Your implementation of the VMF.

## **8. Intellectual Property Rights**

- 8.1 HEFCE on behalf of JISC reserves all its intellectual property rights in the VMF subject to the express rights granted under this Licence.
- 8.2 Any intellectual property rights in any implementation of the VMF which You develop shall, subject to HEFCE's rights in the VMF, belong to You.

## **9. Revocation and effect**

- 9.1 HEFCE on behalf of JISC may revoke this Licence for any reason and at any time and will display notice of such revocation on the VMF Website.
- 9.2 In the event of HEFCE on behalf of JISC revoking this Licence, Your right to continue to use the VMF for the purposes specified in paragraph 3 above will not be affected unless the reason for revocation is:
- 9.2.1 Any breach of this Licence by You; and/or HEFCE is compelled to cease the use of any or all of the VMF in order to comply with either an order by a court of competent legal authority or any applicable law.
- 9.3 Should HEFCE on behalf of JISC be compelled to take any action because of an order by a Court of competent legal authority or any applicable law under paragraph 9.2.1 above, it will post notice accordingly on the VMF Website.

## **10. Governing Law and Jurisdiction**

- 10.1 This Licence shall be governed by English and Welsh law.
- 10.2 The English and Welsh courts will have exclusive jurisdiction over any disputes arising under this Licence.

## **11. Notices**

- 11.1 All notices by HEFCE which are required under this Licence shall be displayed on the VMF Website. Such notices shall be deemed to be given on the day after which they are posted on the VMF Website.
